FIRST FOR HUNTERS®

1. Eligibility

- a. Open to hunters and huntresses from around the world, representing any hunting club or organization.
- b. Applications may be submitted by individuals or by nomination using the official submission form.
- c. Nominees must demonstrate a proven track record of ethical hunting practices and contributions to wildlife conservation.

2. Award Categories:

- a. **Hunter of the Year:** Celebrating an individual who exemplifies ethical hunting and has made a significant impact on wildlife conservation and community engagement.
- b. **Youth Hunter Award:** Recognizing a young hunter (under 22) who demonstrates exceptional hunting skills, leadership, and commitment to conservation efforts.
- c. **Huntress of the Year:** Recognizing a woman who has made outstanding contributions to ethical hunting and conservation efforts.

3. Application Process

- a. Applicants must complete the official application form and provide all required information and supporting materials.
- b. Applications must be submitted by the specified deadline. Late applications will not be considered.
- c. Applications can be submitted online via mail to info@scimiddleeast.org

4. Award Criteria

- a. Commitment to Ethical Hunting: Demonstrating a strong adherence to responsible hunting principles.
- b. Impact on Conservation: Significant contributions to wildlife conservation, habitat preservation, or sustainable hunting practices.
- c. Trophy Achievements: Number and ranking of harvested trophies, all taken according to ethical hunting standards, fair chase practices, and adherence to local and international hunting regulations.

5. Important Dates:

- a. Application Deadline: 31st May 2025
- b. Judging Period: June – August 2025
- c. Winners Announcement: September 2025, during the award ceremony.

6. Judging Panel:

- a. A diverse panel of respected hunters, conservationists, and industry leaders will review all nominations. The jury will select five finalists from each category to be presented at the award ceremony, with the category winner announced on stage.

7. Prizes

- a. Recipients will receive awards and certificates of achievement.
- b. Winners will be acknowledged during the awards ceremony and featured in our annual report, website, and social media platforms.
- c. Additional non-monetary prizes may include recognition plaques, certificates, and opportunities for publicity and networking.

8. General Conditions

- a. The decision of the selection panel is final and binding.
- b. The organizing committee reserves the right to modify the rules and guidelines as necessary.
- c. By submitting an application, applicants agree to comply with all rules and guidelines and to participate in promotional activities related to the award.
